The overall objective of this project is to support and assist the PINK pilot municipalities with the testing, enhancement and implementation of the LG IDMS Toolkit. In his/her role, the Service Providers will be responsible for the following broad scope of work:

- Supporting and guiding improved infrastructure delivery management in the identified local municipalities.
- Assist and facilitate the finalization and implementation of the LG IDMS Toolkit in support of infrastructure delivery within the identified Municipalities
- Facilitate capacity building within the identified municipalities as it relates to infrastructure delivery.
- Working in close collaboration with the PT advisor, provide technical and strategic advice to the Free State or Mpumalanga Provincial Treasury.

The experts will be required to provide their services within the project municipalities in Mpumalanga and Free State provinces in cooperation with the rest of the technical delivery team.

Timeframe of contracting period: Full-time basis for a period ending October 2023.

Qualifications requirements

Tertiary qualification in the built environment is compulsory

General professional experience requirements

- 1. 7 years of professional experience in the Infrastructure Delivery Environment in South Africa in the Provincial or Municipality environments.
- 2. At least 5 years of experience with building professional capacity of infrastructure delivery practitioners (by providing training, facilitation and/or organisation of learning programmes).

Specific professional experience requirements

- 3. Proven practical experience of working successfully within South African municipalities in supporting the Infrastructure Delivery Environment.
- 4. Knowledge and understanding of the legislation and practises in the Infrastructure Delivery Environment.
- Practical project management experience in terms of infrastructure delivery and procurement experience within a Local Municipality (Including developing workplans, budget tracking and reporting).
- Applied knowledge with capacity building / Change Management; At least three assignments performing a Mentoring and/or Coaching role on improving infrastructure delivery management.
- 7. Experience in the implementation of Infrastructure Procurement strategies/models within the Public Sector.
